## **MAKING A RESERVATION**

Alaska Sea Adventures requires a 50% deposit within 10 days of making your reservation. The balance is due by the 90th day prior to your charter date. If the reservation is made less than 90 days prior to charter date, payment is due in full within 10 days of making your reservation. A deposit as well as a signed charter document is required to confirm your reservation. There are no exceptions. The charter document is a written acknowledgment of Alaska Sea Adventures refund and cancellation policies.
